



**MUTUAL COOPERATION AGREEMENT BETWEEN  
KAYSERI UNIVERSITY  
AND  
ANDIJAN INSTITUTE OF AGRICULTURE AND AGROTECHNOLOGIES**

Kayseri University, Mevlana Mahallesi 15 Temmuz Yerleşkesi Kümeevler No:5 38280 Talas / KAYSERİ /Türkiye, represented by its Rector, Prof. Dr. Kurtulus Karamustafa and Andijan Institute of Agriculture and Agrotechnologies, Oliyogh str., 1, Kuyganyar, Andijan region 170600, Uzbekistan, represented by its Vice-Rector Dr. Abdusalom Maxsutaliev have agreed as follows:

**Article 1**

Both universities decide to collaborate as to facilitate and encourage the co-operation and the pedagogical, scientific and technical exchanges at international level. Both institutions believe that mutual benefits can be obtained through collaborative activities, such as the development and promotion of programs which agree by both parties, have set forth the following Mutual Cooperation Agreement

**Article 2:**

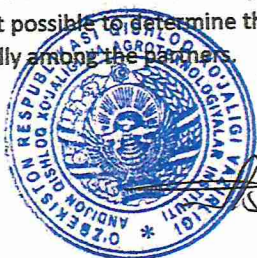
This co-operation may take the following forms:

- a) Exchange of students
- b) Teaching staff exchanges for short-term, medium-term and long-term visits
- c) Exchange of researchers
- d) Joint publications and exchange of papers and publications
- e) Collaboration on joint research subjects
- f) Joint seminars and conferences
- g) Joint management of degree projects and theses.
- h) Joint international conferences, seminars, workshops, research and publication, exchange of faculty members, teaching personnel, and researchers for research, lectures, and academic discussions, exchange of information, including exchanging of library, academic materials and research information, summer programs, joint e-Learning, internships, and exploring opportunities for them to work together on specific projects.

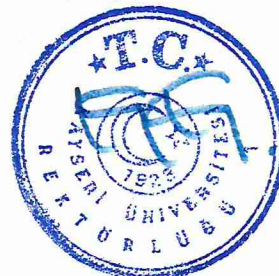
The financial provisions regarding the abovementioned forms of co-operation and the financial obligations of both Parties connected with this Article are subject of additional Annexes to this Agreement.

**Article 3:**

The parties agree that the joint publications, the co-production and the dissemination of the research results will be carried out only by mutual agreement between the parties. In the case of works for which is not possible to determine the participation degree of each party, the possible royalties will be shared equally among the partners.

**Article 4:**

The agreement is concluded for a period of five (5) years. It is subject to cancellation at any time by either party with six months' notice.

The agreement may be extended or amended by mutual written agreement of the parties. Either party may terminate by giving written agreement of the parties in respect to each separate activity.

The conditions, costs and conditions of any joint activity between the parties will be discussed and agreed upon by both parties prior to the commencement of the relevant activity.

The parties will strive to avoid conflicts in the implementation of this Agreement. If any conflicts arise, both parties agree to hold consultations with a view to reaching a peaceful, mutually acceptable solution.

In the case of cancellation, the cooperation activities already started will continue until their term, or at the latest the 31-st August of the relevant year.

The agreement could be renewed by the written approval of the two parties.

**Article 5.**

The signing of this Agreement implies that the signatories will strive to reach the best of their ability, the objectives stated in the Agreement.

**Article 6:**

The present agreement is submitted to approval by the competent academic bodies of each institution and by its official authorities.
